## Alford Land Records in Michigan Submitted by Gil Alford, AAFA #0019, Member AAFA Hall of Fame

Much of the data for this list came from a CD prepared by the Government Land Office, Bureau of Land Management. Most of that data plus other information, including an image of the original certificate, can be found online at <a href="http://www.glorecords.blm.gov">http://www.glorecords.blm.gov</a>.

A brief explanation of the format might be useful. The top line contains the name of the patentee, the date he signed the documents (the date the land left government ownership) and the name of the land office. The bottom line contains a title authority such as 3 stat .566 dated April 24, 1820 setting up cash sale transactions. An exception to the bottom line occurs when there are any AAFA notes in which case they are at the bottom.

The other line/s shows the document number, the county in which the land is located, the aliquot or expression that specifies just what piece of land is involved the piece of the section like the south 40" from Dallas. The section number comes next followed by the township (N or S) and the range (E or W), and finally the acreage. Note that when two or more parcels are involved with the same accession number only one record has the acre count the other shows zero.

All ranges (R) are measured east or west from the 19th (Michigan-Toledo Strip) Meridian. In Michigan there is only one meridian. If one draws a line north and south along the county boundary between Crawford & Oscoda counties and the boundary between Gratiot & Saginaw counties that line will follow the Michigan Meridian.

All townships (T) are measured north or south from a baseline that runs across the state on a line that runs along the county boundaries below Allegan, Barry, Eaton, Ingham, Livingston and Oakland counties.
