

1995 Meeting Report and More Photos

The 1995 meeting of the AAFA was held in Decatur, Alabama, beginning October 13. The meeting began with the workshop on Friday. Gil Alford started the workshop off as only Gil can. He outdid himself at this meeting. He not only had overhead view graphs with lineage information but also had transparency color maps of the U.S. as it looked during a particular period of history as he discussed the westward migration of our Alford ancestors. Lynn Shelley, our newly elected vice-president, assisted Gil in presenting the program. Lynn has done an amazing amount of research concerning Alford's. She shared some of her finds with the audience as well as offering tips on doing research.

In the afternoon session, we were very fortunate to have as a guest speaker Robert S. Davis, Jr., Director of the Family and Regional History Program at Wallace State Community College in Hanceville, Alabama. Mr. Robin Sterling, AAFA #320, made the arrangements for Mr. Davis to speak at the meeting. Mr. Davis has had more than 500 documents published on records, research, and archives, including 24 books. He presented a very informative talk on doing research in both Georgia and Alabama. According to Mr. Davis, there is a wealth of information in these two states that is not normally found in other states. Mr. Davis also stated that he was very impressed by our Association and the amount of information that it has available not only to its members but to the general public as well.

The Friday night reception was well attended. The food was delicious. Every one had a chance to visit old acquaintances as well as make new ones.

The meeting officially began Saturday morning with a "Welcome" issued by Paul W. Alford, AAFA #455. Paul and his wife, Jean, were the hosts for the event. Everyone who attended owes Paul and Jean a debt of gratitude for all their work in preparing for the meeting—including, for the first time, a copy machine available on site to make copies of the numerous documents available in the Research Room.

Before Ben Alford, AAFA President, officially called the meeting to order, some door prizes were handed out. Our editor, Pam Thompson, was awarded the prize for having traveled the farthest to the meeting. As you probably know, Pam lives in California. However, she only beat out Jo Carrigan's group by a few miles! Paul Alford, who lives in Decatur, won for having traveled the shortest distance. Vesta Alford Giddings, AAFA #233, won for being the most senior member present. Another senior member, the late Oliver Perry Alford, was not present when the award was handed out, or he would have won—O.P. had about a year on Vesta.

Ben Alford then officially called the meeting to order. Ben gave a report on actions by the President since the last meeting. He then called on the following people for their reports:

The meeting site for next year was discussed. Al Alford, Events Coordinator, informed the membership about what he had encountered in trying to

arrange for hotel accommodations. After some discussion, a vote was taken and California was reaffirmed as the meeting locale for 1997. Some mention was made of forming a caravan for the trip to California. This would consist of meeting at a predetermined location and traveling not necessarily together but rather staying at the same motels along the route, sightseeing at the same attractions, etc.

A vote was also taken for the meeting site in 1998. Jimmie Alford, AAFA #500, volunteered to help organize and advertise the '98 meeting if it could be held in Kentucky. Jimmie's ancestors are from Kentucky. The vote was in favor of Kentucky as the 1998 meeting site, a city to be determined at a later date by Al and Jimmie.

The Saturday night buffet was attended by 136+ people, the most attendance by any one event for the entire meeting. An official with the City of Decatur made an appearance dressed as Stephen Decatur, naval hero of the War of 1812 and for whom the city is named. He delivered Decatur's official welcome to the city. The Board of Directors met Friday night after the reception. Wick Alford, the late Pooley Alford, Gil Alford, and D.L. Alford resigned effective at the end of the meeting. James P. Alford had already submitted his resignation

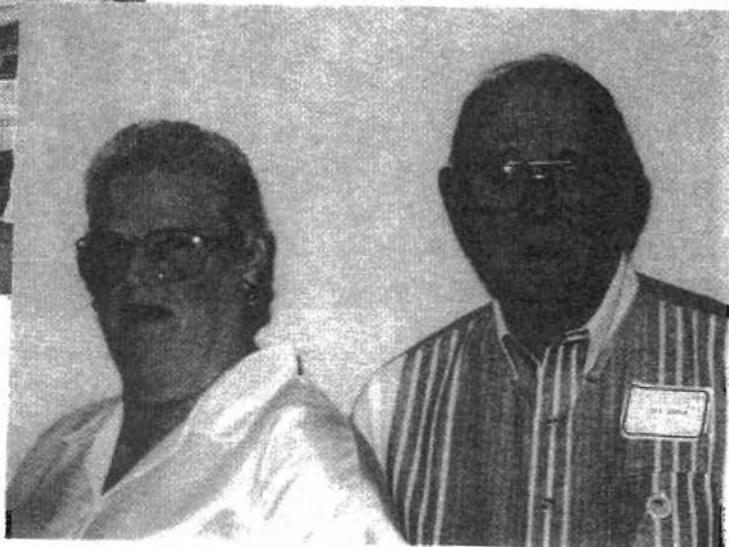
