## "Alfords" in the 1860 Census

This census report is a product of the AAFA census team. The initial list of names to be extracted was prepared from published census indexes and, in some cases, supplemented by unindexed entries. An every name extraction was performed using the microfilm as a source and the result verified for completeness and accuracy.

The following data is not intended to reflect either the "true" facts or what descendant families believe to be the facts. It is also not guaranteed to be without error. Nevertheless, every attempt has been made to provide a complete and faithful representation of the information recorded on the original enumeration forms.

The categories on each line appear in the following order: name, sex, age in years or months (two columns), color (assumed to be white unless shown otherwise), birth place, \*MSR, property value and occupation.

\* There may be any one of three entries:

M = married within the year

S = attended school within the year

R = can't read or write (or just W if can read but not write)

Birthplace is shown with the approved postal abbreviations for states in the U.S.

The order of the information in the two line family header: the name of the post office, township or political subdivision, county, and microfilm roll number. On the 2nd line: census page number, census dwelling or house number, census family number, and the enumeration date.

#### Conclusions.

The full maiden name of Aunt Belle Newton was Susan Isabelle Alford. Since she has been identified under various names, what may be true for all of the forms of her name is true for all forms of her name. What may be false for one form of her name is false for all forms of her name. This is true because each form represents the one and same person, Belle Newton.

Here is an example of that application. Susan I. Alford's father was Robert Alford. Since Susan I. Alford and Belle Newton are the one and same person, then it may be concluded, with reasonably certainty, that Belle Newton's father was Robert Alford.

This application may be used fairly with all of the various forms of Belle Newton's name, including the use of her family name for her brothers, James William Johnson and Richard Joseph Johnson.
