From time to time, there are also nominees for induction into the AAFA Hall of Fame. This is not a yearly process but only occurs when the Board feels



I was nine at the time. We were the typical poor family, no running water, etc., but we were of strong spirit as with most Alfords. Even though my Dad had very little formal education, he valued learning and was very learned in his own way. His sense of values and commitment to helping others is a big part of my values."

There were plenty of door prizes as well as the prizes in the annual raffle. Peggy Wood, Earline Alford, Ramona Darden, Lynn Shelley, and Elroy Alford donated prizes for the raffle. There were simply too many awarded to list them all here. Of course, one of the big events of the night was the announcement of the winners in the baby photo contest. and Spanish occupations through the westward expansion years to present. Our compliments to the ranger who allowed us to sit while he lectured and to his voice which was strong enough for "older ears" to hear and understand. A trip to the Cahokia Mounds began our Thursday morning tour with a movie about the excavation of the mounds. After the movie, we toured a wonderful museum with great life-like exhibits of the ancient city of Cahokia, from about 700 A.D. to 1400 A.D. Some of our brave members climbed the Monks Mound to the top, which consisted of approximately 100 steps after which they were caught sleeping in the tour bus, but they will not admit the snooze!

Our last stop on Thursday was the Missouri History Museum which had three permanent exhibit galleries that look at the lives of St. Louis citizens from the city's earliest days to the present. A replica of Charles Lindbergh's "Spirit of St. Louis" is suspended in the Grand Hall. This museum brings Missouri History to life.

We ended our tour with a stop at Union Station, which was once one of the busiest and largest passenger rail stations in the world. Redeveloped as an urban market place, it is now the home to a hotel and a festival market place of shops, restaurants and clubs.
