Mississippi "Alford" Federal Land Records

Based on the U.S. Bureau of Land on line data with some AAFA notes to explain or identify.

The AAFA notes will be shown when the subjects name appears the first time, but not in additional records immediately following. In some cases there are cross reference notes.

It is not our purpose to tell you all we know about the subject in these notes. We do want to identify them sufficiently for you to know who the subject is. For a more complete discussion of the subject 'Alford' you need to see his genealogy, or in some cases family group records on the website <www.alfordassociation.org>.

In some cases two different names were included on the land certificate. Both names will appear below in order thus there is some 'duplication' of information. There are exceptions.

The second entry on the top line, after the name, is not from the land records. It is an AAFA family branch identification- enclosed in curley brackets { }.

On the top (numbered) line of each paragraph you will see either "Cash Sale" or "Homestead" (there is one that says "Warrant"). AAFA is making some effort to acquire the "Land-Entry Case Files" for the homesteads from the National Archives. There are 34 homestead cases. At a cost of \$17.75 per case there will be some limitation.

Henry, born about 1799, was the son of Ferrell & Phebe Alford. His wife was named "Annis" in 1850 and it might have been the Annis Cottengham who married Henry B. Alford in Copiah Co. in 1825. They were enumerated in 1840 Yazoo Co. with five children. It was probably them in 1830 Hinds Co. with three children.

AAFA NOTE:

We cannot be sure just who "Hughie" Alford was. It was a fairly common name with the Alfords of that area, but not of this period. There was Hughey Alford, son of Gordon & Delliah Alford, a black family enumerated in Pike Co. in 1880, but he was only ten years old which should rule him out. Unless they were concealed by use of initials in the census there was no other Hugh or Hughie in Pike Co. in 1880. There was no Hugh or Hughie at all in Pike Co. in the 1900 census. Note that until 1910 what is known as Walthall Co., was a part of Pike Co. Perhaps something can be learned if or when the land-entry case file is purchased by AAFA.

This is probably the Jackson Alford who was enumerated in 1850 Yazoo Co. Son of Ferrell and Phebe Alford. He was born about 1814 in Tennessee according to that census, but his parents came from Georgia. He married Elizabeth Ellison 1849 in Yazoo Co. and they soon moved to Morehouse Parish, LA.
