Section Fifth

In our most thorough investigations and research of this section of the family record did not enable us to a positive proof of his parental relations were - but being born in the same locality and with a brother named John Alford and was called the "Fighting Major", a "farmer soldier", fighter of some note - and was with the Connecticut Continentals as bugler and fife Major during the Revolutionary War and by this concluded he was the second son of (Col. Benedict Alford was written in and crossed out and 'not known' written above it, probably done after the entire manuscript was completed) and his name was

Major James Alford

He was born in Windsor, Conn., about the year 1760 or 1761 and was by occupation a farmer and soldier. And tradition is given by descendants that he was a bugler and fife Major and served in the Revolutionary War. And was with an elder brother whose name was John Alford and was with the Continentals and again it is stated that the two brothers were with the Continental troops who were defeated by the British and Indians during the Revolutionary War, in that part of Virginia near North Carolina and that James was one of those two brothers and that they afterwards settled in Monroe County, Virginia. He was married and had a family - who his wife was is not known and is said died "many years previous t 1830". We have had two family records who are supposed to be his sons and descendants. How many more children he had is not known. And if we are able to procure any further record will place it in last pages of this book. I also have a printer record of one called "Tersie Alford" he could have been a son of Major James Alford and have another record of a John Alford we cannot find any conclusive record and placed his name and record among the Carolina Alfords.

The first record we give is one of the two records who was named Henry Alford

He was born in Monroe County, Virginia, about the year 1784 and was by occupation a farmer. And in all probability son of Major James Alford or "the missing link" page 16(original page #) whom his descendants claim. He married Miss Ellen Weller about the year 1812 and about the year 1830 or 5 they moved to the state of Indiana and took up land and settled in Greenfield, Hancock County, Indiana, where he died - date not given. They had nine children.

Their eldest child was a son who was named

James Alford - see next record

Their second child was a son who was named

Logan Alford - he was born in Monroe County, Virginia about the year 1815 and was by occupation a farmer. He married Miss Tilda Jones and they resided in Greenfield, Hancock County, Indiana, where he died - no family record given.

Their third child was a son who was named

Andrew Alford - he was born in Monroe County, Virginia, about the year 1817, occupation a farmer. He died in Hamilton County, Indiana - no date or family record given.

Their fourth child was a son who was named

Elijah Alford - he was born in Monroe County, Virginia about the year 1819. He died at Preble County, Ohio - no date or record given.

Their fifth child was a son who was named

Rev. Joseph Alford - he was born in Monroe County, Virginia, about the year 1821. He united with the Church and was ordained a Minister of the Gospel. He married Miss Emaline Cartright. He died at Contie, Ohio - no date or family record given.

Their sixth child was a daughter who was named

Pauly Alford(Bowman) - she was born in Monroe County, Virginia about the year 1823. She married Mr. Joseph Bowman. They settled in Iowa, where she died - no other record.

Their seventh child was a daughter who was named

Ester Alford(Harper) - she was born in Monroe County, Virginia, about the year 1827. She married Mr. Harper and she died in Greenfield, Hancock County, Indiana - no date or record given.

Their eighth child was a daughter who was named

Sally Alford(Hasen) - she was born in Monroe County, Virginia, about the year 1827 (which must have been twin to Ester). She married Mr. Rev. Hasen - no further record given.

Their ninth child was a son who was named

Robert Alford - he was born in Monroe County, Virginia, about the year 1829, supposedly he was a farmer. He married Miss Harger and they settled in Decatur, Illinois, where he died - no other record.

This completes all the names and family record of Henry and Ellen Alford.

The next in line of record is of their oldest son who was named

James Alford

He was born in Monroe County, Virginia, Nov. 28, 1813 and by occupation a farmer and stock raiser. He married Miss Nancy Bowman in 1834 and they settled in Greenfield, Hancock County, Indiana, where he died May 24, 1847 in his 34th year. They had five children.

Their eldest child was a daughter who was named

Sari Jane Alford(Beck) - she was born in Greenfield, Hancock County, Indiana, Feb. 22, 1836. She married Mr. John Beck - he was by occupation a farmer. They moved to Salonine(sic) City, Kansas where they at present reside - no other record.

Their second child was a daughter who was named

Marie Ellen Alford(Crist) - she was born in Greenfield, Hancock County, Indiana, Nov. 25, 1834. She married Mr. G. P. Crist. She died at Greenfield, May 26, 1874 in her 37th year.

Their third child was a daughter who was named

Malissa A. Alford(Winman) - she was born in Greenfield, Hancock County, Indiana, Feb. 19, 1839. She married Mr. Isaac L. Winman and they had five children, the eldest was a son named

H. G. Winman - he was born in Greenfield, Indiana, June 16,1860. He married Miss Flora Belle. He is engaged in the chemical world and resides at Fostorville, Indiana.

Their second child was a son who was named

L. O. Winman - he was born in Greenfield, Indiana, Mar. 3, 1870, occupation mercantile clerk. He married Miss Ella R. Collins, Dec. 24, 1893. They reside at Fostorville, Indiana.

Their third child was a daughter who was named

Margett W. Alford(McCarty) - she was born in Greenfield, Indiana, Feb. 14,1841. She married Mr. Wesley McCarty in 1859. They moved to Kansas where she died in 1868. Her husband still resides at Sutphin Springs, Kansas.

Their fifth child was a daughter who was named

Hannah Elislde Alford - she was born in Greenfield, Indiana, 25 April 1844 - died in childhood.

This completes all the names and Family Record of James and Nancy Alford.

The next in line of record is of the supposed youngest son of Major James Alford who was named Robert Alford

He was born in Monroe County, Virginia, April 5, 1805 and was by occupation a farmer. He married Miss Sarah Cart, May 25, 1827. She was born in Monroe County, Virginia, May 5, 1807. They left Monroe County coming west and settled in Elkhart County, Indiana in 1836 and he died in South Bend, Indiana, May 25, 1889 in his 84th year. His wife died in Goshen, Indiana, Feb. 17, 1880 in her 71st year. They had eleven children.

Their eldest child was a daughter who was named

Elizabeth Alford(McDowell) - she was born in Monroe County, Virginia, in 1829. He married Mr. Wiliam McDowell in 1848. They resided at Goshen, Indiana. She died there in 1849.

Their second-child was a son who was named

George W. Alford - see next record

Their third child was a daughter who was named

Sara A. Alford(Swart) - she was born in Monroe County, Virginia, Dec. 5, 1832. She married Mr. Phebe Swart, Feb. 12, 1856. He was born in Netherlands, Holland, Dec. 5, 1835 and by occupation a farmer and Ex. Co. Supt. of Public Schools and they resided at Goshen, Indiana, where she died Feb. 29, 1888 in her 56th year. They had six children.

Their eldest child was a son who was named

John H. Swart - he was born Feb. 19, 1857 and by profession a teacher. He married Miss Anna Kunsley, Oct. 6, 1887. They reside at Goshen, Indiana.

Their second child was a son who was named
