} Humbly complaining your

Petitioners show unto your worships that many years ago Lodwick Alford departed this life having duly made his last will and testament, which has been proven and recorded, a copy of which is herewith filed as a part of their petition. And that in and by said will among other things he devised and bequeathed as follows to wit "I leave to my daughter Mary Alford one negro by the name of Dafne & also my old mill land on Seypress creek adjoining Robert Butler & others during her natural life & after her death my will & desire is that her son Baily Alford shall have it to him & his heirs forever – And also my will and desire is that said negro and all her increase to be equaly divided among my said daughter's children after her death to them & their heirs forever – And your Petitioners show that the aforesaid Mary Alford departed this life Intestate some time during the present year – that said Dafne is also dead, but the said negro had the following children & increase (to wit) Stepney, Annice and Lethram?/Litheau?/or ? – And that said Mary Alford had the following children (to wit) _____ wife of Willie Clifton, Eli Alford wife of Randel Redding, Gilbert Alford, Winney wife

of John Mitchell, Dilly wife of Martin High – Willie Butler & wife - [wife of Martin High – crossed out] wife of Baily Clifton and Baily Alford - That the said Baily Alford died several years since and your Petitioner Joseph Fowler is his administrator - And your Petitioner Willie Clifton shows that he is the purchaser & owner of the right title interest of the following distributers & children in said slaves (to wit) of the shares of Eli Alford, Randal Redding & wife Martin High & wife & Baily Clifton & wife and has the Bills of Sale and deeds from them ready to exhibit and produce whenever he shall be required so to do and prays that their sharing and interest in said slaves may be decreed to be

secured delivered or paid to him. – And your Petitioners being ordered that they are tenants in common of said slaves wish to have said tenancy disolved and their shares in said negro slaves on this proceed of the sales of them seperated & secured for their use & benefit. And they further show that there being only three negro slaves of different ages & values and many legatees in distributers, that a division of said slaves cannot be made without injury to some of the parties interested- and pray your worships to decree a sale of said slaves and to appoint the Clerk in some other fit person a Commissioner to make a sale of them on a credit of not less than six months after giving thirty days notice by public ad vertisement in three or more public places of the home place and times of sale – and that the person so appointed take bond and good securities of the purchasers for the purchasers money and report all his proceedings

in the premises in this case to the next Court – and that your worships secure to each of the legatees & Petitioners interested his or her valuable share in severally* of the proceeds of such sales - And that said sale of slaves be made according to the act of assembly in such cases provided. And your Petitioners pray for such other & further relief as the nature of their care requires. (sgd) Geo. W. Haywood For Petitioners

* Definition from Black's Law Dictionary: **Severally.** Distinctly, separately, apart from others. When applied to a number of persons, the expression *severally liable* usually implies that each one is liable alone.
