DRAFT - Three Generations - DRAFT Some of the Known Descendants of John Alford who died 1748 VA

[This is a draft copy of a work in progress. It is known to be incomplete and probably contains some error. Use it only as a clue as to where to search for more reliable information. This posting was made in an effort to learn more about the known DNA connection between this branch and that of the William Alford b. 1804 in VA, supposedly of Montgomery Co., VA who married Elizabeth Penner of Montgomery Co., VA, about 1821 in Kentucky. A similar genealogy is being posted here for that branch of the Alford family.]

1. **John Alford** #66 b. 1696, m. **Mary** _____ #67, d. after 1758, Frederick Co., VA ??. John died 1748, Frederick Co., VA.

Nothing is really KNOWN about John's birth date or place. While he died in Frederick County he was probably present in Orange County from which Frederick was made in 1735. He made his will Nov 13, 1748 and it was admitted to probate January 4, 1748 so he died within that period of less than 60 days.

He was first found in Orange Co., VA in 1735. Frederick Co. was formed from Orange and Augusta in 1738. Lynn Shelley email 8/24/99

He was fairly young when he died because all of his children were under 19 and the wording of the will suggested the wife might remarry.

The late Mrs. Tressie Bowman reported that he was the son of John Alford and Elizabeth. That would be the John who died 1702 in Dorchester County, Maryland, whose will dated October 20, 1702 was probated November 11, 1702 and is filed in Box 1, Folder 6 Dorchester/Carolina Co., MD wills-1702. Other children of John and Elizabeth Alford were Matthais and Joseph.

John and Matthias were the executor's of the older John Alfords will. Son John is, according to Mrs. Bowman, supposed to have married Mary Dawson 1717 in Dorchester County, MD. [later proved that Mary Dawson married Edward Alford.] Matthias married Celeninor Godward and Joseph married 1735 Margaret Richardson.

Mike Heazel, AAFA #0664 has a theory that would make the subject the probable grandson of this John & Elizabeth Alford. AAFA member Joe Alford, #1058 has a similar theory- showing the subject to be the son of Matthais Alford who was the son of John & Elizabeth. Perhaps continued research will reveal evidence needed to prove a connection.

If and when any credibility can be proven to this connection the data will be take out of this note form and the Alfords entered as subjects in the Genealogy.

Lynn Shelley, AAFA research leader, gives the following reasons for placing John as the first child: (1) He is listed first in the will. (2) He got 2 horses, 1 Negro and the still which is to help support his mother, others only got 1 horse (except Priscilla). (3) John gets inheritance at age 19 or marriage of mother; others get theirs only at their marriage. (4) At marriage of mother, John becomes

responsible for siblings' inheritance. (5) John's age - not yet 19 - only one mentioned. If others were older, wouldn't they support mother, be executors, etc. (6) 1754 Frederick County Deed indicates John is acting on behalf of siblings, William and Acquilla, who it is assumed were still underage. (7) William votes in Frederick County, in 1761 but not in 1758- had he just turned 21- or was he just then a landowner?

In the name of God Amen I John Alford of Frederick County being very sick and weak of body but in perfect health of mind & Memory Do make constitute & appoint this my last will & Testament in manner & form following. First & principally I give my Soul to Almighty God, my Body I give to the Earth to be decently Buried at the Discretion of my Executrix hereafter mentioned and for what Worldly Estate it hath pleased God to bless me with my will is that it may be Disposed of in the following manner.

Imprimis I Give to my beloved wife Mary Alford the use & benefit of all my Estate during her Natural Life except as is hereafter Excepted and after Decease to be equally Divided amongst all my Children Male & female except also the Specifick Legacys hereafter mentioned.

Item I Give to my Son John Alford one Negro Boy named Casar my Still with the appurtenances thereunto belonging my young Dark Bay horse called Prince & a young Natural pacing Mare with a Blaize in her face to be delivered to him when he shall arrive to the age of Ninteen Years unless his Mother Marry before he arrives to that Age & then my Will is that my Said Son Shall be possessed of the above Legacies Directly on her Said Marriage always provided that my Said Wife Mary shall have & enjoy half the profits arising & accruing by the Said Still During all the time that she shall remain a Widow & my will further is that if my Said Son John Should Die without Heirs & before his Mother that then the before Bequeathed Legacies Shall be equally Divided amongst all the rest of my Children - Males & females & further it is my Will that Sd son John Shall not Enjoy or have any other part of my Estate or any Share with my other Children than what is above given & bequeathed to him and further it is my Will that if my wife Marry before or after my said Son John Arrives to the Age of Nineteen years that he after his Arrival to that Age & such her Marriage shall have & take the Estate belonging to my other Children into his hands.

Item I give to my Daughter Mary Alford one Natural pacing Young Bay Mare commonly called hers to be Delivered to her at the Day of her Marriage.

Item I Give to my son Thomas Alford a Young black pacing Mare commonly Called his to be Delivered to him at the Day of his Marrying.

Item I Give to my Son William Alford a Young Dark Bay Yearling pacing horse Commonly called his to be Delivered to him at the Day of his Marrying.

Item I Give to my Daughter Priscilla Alford one Negro Girl called Licia to be Delivered her after the Decease of my Wife. Also one Mare Colt that came of a black Mare called Flower to be Delivered to her at the Day of her Marriage.

Item I Give to my Daughter Aquilla Alford a young horse which Came of my Roan Mare to be Delivered to her at the Day of her marriage.

Lastly I Nominate & appoint my Loving Wife Mary Alford my Sole Executrix of this my Last Will & Testament hereby Revoking all other Wills before by me made. In Witness whereof I have hereunto Set my hand & Seal the 13th day of November 1748.

This Will of John Alford Deceased was presented into Court by Mary Alford the Executrix therin named who in open Court refused to abide by the S'd Will. John Harman & John Peverley two of the witnesses thereto having on Oath proved the Same & John Peverly on his Oath Declared that he saw Richard Robinson the other witness Sign the Same then & Will is admitted to Record.

Do make or cause to be made a true & perfect Inventory of all & singular the Goods Chattels & Credits of the said Dec'd which have or shall come to the Hands or possession or knowledge of her the said Mary or into the hands or possession of any other person or persons for her: and the same so made do Exhibit or cause to be Exhibited into the County Court of Frederick at such time as she shall be thereunto required by the said Court and the same Goods Chattels and Credits and all other the Goods Chattels and Credits of the said Deceased at the time of his Death which at any time after shall come to the hands or possession of the said Mary or into the hands of or possession of any other person or persons for her do will and truly administrated according to Law. And further do make a just and true Account of her Actings and Doings therein when thereto required by the said Court and all the rest & residue of the said Goods Chattels and Credits which shall be found remaining upon the said Administratrix Account the same being first examined and allowed by the Justices of the Court for the time being shall deliver and pay to such person or persons respectively as the said Justices by their order of Judgement shall Direct pursuant to the Laws in that case made and provided; And if it shall herafter Appear that any other last will and testament was made by the Deceased and the Executor or Executors therein named do exhibit the same into the said court making Request to have it allowed and approved accordingly. John and wife Jane sold land in Rockingham County by February 1787 but were still living in Rockingham when the tax list was made. His will was written July 2 1794 in Greenbrier County but was not probated until 1810 (in Monroe County which was formed from part of Greenbrier in 1799).

This is probably the family with 10 white souls in 1784. This John Alford is the one who is often listed as the son of the John Alford of the 1748 Frederick Co. VA will. Although this is a possibility, no proof of this has been found.

The Will of John Alford

In the name of God, Amen. Being indisposed and weak in body but perfect mind and sound of memory and I thank God for it, I do make this my last will and Testament, hereby making void all other and former wills by me made, either by word or in writing and this to be taken for my last will and no other.

Impremis: My will is for my three sons, Thomas, John and James to have my lands. My son Thomas to have that part whereon he now lives, John to have his part next Dixon, James to have that part whereon I now live and all the improvements thereunto belonging, all but the camp field. And that Thomas is to have, the land to be equally divided betwixt them three.

I bequeath to my loving wife Jane Alford the third of all that shall be raised on the said plantation by my son for her maintenance.

I bequeath to my three daughters Margaret, Sarah and Jane Alford a feather bed apiece to be paid by Thomas, John and James Alford, and it is my will that Thomas is to give my daughter my daughter Amy [Anny?] a new woman saddle and my son John and James is to give her a beast worth two pounds and my son Thomas to school my daughter Jane and my son John to school my daughter Margaret. And James is to school my daughter Sarah and my son Thos. is to pay 3 pounds 6 shillings and nine pence the last payment of the land.

I bequeath to my daughter Mary Alford one cow to be given her by her mother and the remain of my Estate to be at the disposal of my loving wife Jane Alford and I hereby make and appoint my loving wife Jane Alford Executrix and my loving son John Alford Executor of this my last will and Testament, hereby revoke all and disannul void all former wills and bequeaths by me made and declare this only to be my last will and Testament. In witness I have hereunto set my hand and seal this second day of July one thousand seven hundred and ninty four.

I bequeath to my loving wife her choice of the sugar camps during her natural life.

Jane: Jane Alford was a head of household until 1801 when she no longer appeared on tax lists. She lived with her son James until her death. All of the children lived in the Greenbrier/Monroe County area, even though several marriages occurred in other counties.

The Will of Thomas Alford

In the name of God Amen. I Thomas Alford of the County of Wythe, state of Virginia being sick and indisposed in Body but of a sound and disposing mind and memory do make and declare this to be my last Will and Testament in the following manner to wit:

Imprimis I will that all my just debts and funeral expenses be discharged out of my personal estate, the residue after paying my just debts I leave and bequeath to my son Moses Alford who is to maintain his mother Elizabeth Alford during her natural life and to pay his Brothers and Sisters and to the Representatives of those who may be dead One dollar Currency to each of them hereby making void all former Wills by me made declaring and publishing this to be my Last Will and Testament.

Lastly I do constitute and appoint Elizabeth Alford my wife and Moses [the name Thomas was originally written here and is scratched through and the name Moses written above] Alford my son Executors to this my will with full power and Authority to Execute everything that may appear after my decease necessary.

In Witness whereof I have hereunto subscribed my name and affixed my seal this 14th day of November 1805.

Wythe County December Court 1805 This the last Will and Testament of Thomas Alford Deceased was proven in Court by the oaths of Thomas Boyd, Humphrey Ellis and Henry Christly, Witnesses thereto and the same is ordered to be Recorded. Test. John P. Matthews D. C.

This Will is recorded in Wythe County, Virginia in Will Book No. 1, Page 338. Their children have traditionally been shown as born in Wythe County. That county was not formed until 1789/90. It came from Montgomery 1777, it from Fincastle 1772. it from Botetourt 1770 and it from Augusta which was created 1738/45.

Lynn Shelley: He got a VA Land Grant in 1762 in Ahmerst Co., VA and sold it in 1768 at which time Elizabeth was named as his wife and William was a witness.

Ruth Moran shows his death as Nov/Dec 1805. He wrote his will November 14, 1805 and probably died within the month after writing the will, as probate occured in Dec. 1805 - unless a smudge is obscuring a "1806."

[Note that the Jewell Gallagher sketch listed him only as a possible son of John Alford.- She lacked proof also.]

Elizabeth: Some think Field was her surname. Need proof or correct data. There is no proof of when she died, but she was alive when Thomas wrote his will, Nov 14, 1805. The 1805/06 used could be date no longer listed on tax records. She might have been living with son Moses.

It was not him who was in the Virginia Sea Service in the Revolutionary War he was likely born before 1776. It must be another Thomas, who based on the 1830 census was born 1750-60. It would have been he who married Susannah Dillard Kennedy. At this time we don't know where to put Thomas 2 and Susannah.

The following is from an email sent by David Howard (AAFA 0988) to Gil Alford, Dec. 4, 1997. "I do not believe that Thomas Alford who married Frances Crisp died in VA. Nor do I think he married Susannah Dillard. That must have been another Thomas Alford. Thomas & Frances (Crisp) Alford had, so far as I know, only two children, Wm R, and John C. The first three names listed in my g grandmother's Bible are: Thomas Alford (b Oct. 5, 1767), Wm. R. Alford (b Sept 5, 1796) & John C. Alford (b Mar. 28, 1798). John C was my g grandmother's father. There is a Power of Attorney filed in Nelson Co. VA that is signed by Thomas, Wm. R. & Jn. C. Alford - 'of Marshall Co, TN.' I have sent for a copy of this instrument to check the date, but I think it must date from late 1836 or after & concerns the land left in Nelson Co, to Frances Crisp Alford by her father, mother & Sister - Wm., Lucy & Peggy. This was probably a settleing of the estate after Frances died in 1838. Also, Marshall Co. TN was not formed until 1836. There is listed the death date of Oct. 26, 1836 for "Frances Alford" in my g grandmother/s Bible. I am not ABSOLUTELY sure this is Frances Crisp, but I feel comfortablel with the assumption that it is. Thomas is listed in the 1820 census of Rutherford Co. TN with one male over 45, one female 26 to 45 & two males 18 to 26. This certainly looks like the family of Thomas & Frances & their two sons. The info that you sent lists Thomas, who married F. Crisp, as the bro of John Alford, who married Eliz. Bibb. This has been my theory for a long time, but I could not prove it. It makes sense that both bros came to TN, along with the sister, who married Wm. W. Key. Is it certain that their father, William Alford, died in Nelson Co., VA? I ask this because Wm. Alford had property on Duck River in Davidson Co. TN as early as Sept 20, 1790 & March 3 1791. Who was this William Alford? (This info from Davidson Co. Land Records, 1788-1793, pp. 28, 32, 33.) Duck River runs through Marshall Co., TN (not Davidson Co. today) Well, these are just a few things I'd like for the members to ponder on and help me with. I must close, but will send more soon."

The following are excerpts from a report on a Virginia research trip in 1994 made by Diane Etchison AAFA#0656 in connection with the 1994 AAFA meeting in Richmond VA.

I'm afraid I didn't solve very many problems, but I did confirm that the William Alford who married Lucinda Alford in Amherst in 1804 was not the son of William of Amherst. The marriage records that had been compiled by the Amherst County courthouse clerk stated that Lucinda was William's daughter. On the off chance that the clerk had made an error, I checked the original marriage bond in the Amherst County courthouse. Sure enough, the marriage bond was attached to a separate note written by William Alford asking the clerk to grant a marriage license so that Lucinda Alford, his daughter, and William Alford could be married. I even compared the signatures of the groom and the father - they were definitely different. So, while William Jr may still be Pearigens' ancestor, he could not have been William Sr's son.

I did find out a few things about William Jr. He did not appear on the personal tax rolls in Amherst Co until 1806, at which time he paid taxes for one white male over 16 (himself) and one horse. In 1807 he was listed as William Jr (but I'm told the Jr/Sr designation simply indicated who was older and was not an indication of relatedness). There were no tax records in 1808 and by then Amherst Co was portioned into Nelson Co and the personal tax rolls of Nelson Co for the first few years were partially or completely unreadable. That's about the time all the Alford's appeared to have left. In 1811 there were no Alford's in Amherst or Nelson Co. (although there was an unrelated Thomas Alfred, the one who married Susannah Kennady)

William Jr is mentioned in William Sr's probate records. Unfortunately, I was unable to copy the records because the Nelson County Courthouse didn't have a copy machine capable of handling the long format. I hand-copied most of it and transcription is enclosed. I didn't get all of the household inventory, but did get the names of the people settling their debt to or purchasing from the estate. William and Thomas Alford and Joseph Austin are listed.

One thing that puzzles me somewhat is the fact that William married Lucinda in 1804 yet wasn't on the Amherst tax records until 1806. I've suggested to Vesta that she might try looking at the 1804~1805 tax records of other counties in Va for stray William Alfords. He might have taken his new bride home and then decided to join the crew in Amherst a year or two later.

I think that it is very likely that William Jr is Pearigen's ancestor since he, along with the rest of

the Alford's, left Amherst at about the same time and two William Alfords showed up in Tenn shortly thereafter (one of them being John-of Amherst's son). He must have lost his first wife, Lucinda, very early and then married the daughter or granddaughter (Sally) of another Amherst resident, William Hollingsworth in Tenn. Hollingsworth's name crops up everywhere in the Alford deed/probate records. He was the next door neighbor of William Alford and in fact he sold William some of his land in 1779. He was also the administrator of William's estate. There was also a William Hollingsworth Jr. on the tax rolls. I found a book listing for a Hollingsworth genealogy in the National Genealogy Society that might be worth examining for Alford connections.
