A History of Young Co., Tx. by Carrie J. Crouch

J. H. ALFORD

J. H. Alford was born on Dec. 2, 1837, in TN, where he remained until after the Civil War. On Sept. 19, 1875, he married Amelia Brim, and two years later they moved to Young Co. Here they first settled in a large home on the river and took their place among the ploneers.

Among the Alford grandchildren who served in WWII was Lt Colonel Malcolm Kenneth Martin etc. Donald Alford was with the Air Force from Aug. 1942 to Sept. 1945 and on 11 June 1949 he was married to Gertrude Waller. Robert Morris Newby mar. to Ruth Hickman on 15 June 1941, he served with the US Navy etc...

Mrs. Alford died on May 26, 1942, leaving her children, Mrs. W. B. Pounds, Mrs. Clatle Patton, Charles Alford, John Alford, Mrs. Annie Newby, Mrs. Lud Martin, Mrs. Jessie Fain, and James Britton Alford who died Aug. 20, 1942.
