John C. Alford

I have an old ragged sheet of yellow legal paper that was the beginning of my journey to identify John C. Alford, my great, great, grandfather. According to my grandmother Ola Mae Gore Palmer, her grandfather John C. Alford married Sara Ann Jones and his sister (her grandmother) Susan Alford married Elias Gore. Susan Alford and Elias Gore had a son, Edward Pinckney Gore. John C. Alford and Sara Ann Crawford had a daughter named Louisa Jane Alford. Edward and Louisa married (they were first cousins) and their eldest daughter was my grandmother, Ola Mae Gore.

Many miles have been traveled and many hours spent in an attempt to identify the parents of John C. Alford. The Alford Association has an immense data bank on Alfords, including DNA, but they do not place John C. Alford within their genealogy.

A History of Marion County by Sellars discusses the migration of the Alfords from North Carolina. According to Sellars, Neill, James L. and Lodwick B. Alford came to Marion. South Carolina. Neill Alford had a large family with a son named John. They lived on Big Reedy Creek nears Rains. In addition to the Marion Alfords, there were Horry Alfords to consider but Grandma Palmer (Ola Mae Gore Palmer) said we were Catfish Alfords from Marion.

The first Marion, SC Alford I found was James, enumerated in the 1800 South Carolina Federal Census for Craven District. The 1820 census lists only a Peachman Alford. The 1830 census has four Alfords, Neil, James, James, and Elias. In the 1840 Marion District census there are seven Alfords enumerated, Neil, LB, James, Elias, Moses, William, and Joel.

My John C. Alford was born c1830 but I have been unable to document his parents. My research shows that John's story is intertwined with that of the Jones and Gore families (two other of my family lines). Reubin Jones had a daughter by his second wife, Louisa, named Rhoda, born c1861. This was proven by the will of Reubin Jones. Also proven was the marriage of another daughter, Sara Ann Jones, to John C. Alford; thus Rubin is the father-in-law of John C. Alford. There are numerous documents at the Marion County Archives documenting this relationship.

The 1850 Marion District census lists a Prudence Alford, HOH, with six children. Since Prudence does not appear in an earlier census it could be presumed that she was an unmarried Alford, or her husband died before 1850. (Note: The Alford Association suggests that Prudence was married to an unknown Alford. She had a son William N. who established his own household in 1850.) Prudence was enumerated with another son, John, and daughters Rebecca, Sarah, Elizabeth, Louisa, and Prudence. I suggest that John Alford, son of Prudence is my John C. Alford.

In 1860 Jon C. Alford is in Mars Bluff, Marion, South Carolina, with wife Sarah A. Alford, and daughter S. R. (Sarah Rebecca) Alford. His father-in-law, Reubin Jones, is now married to Louisa Alford, the sister of John C. Alford. (Note: During the Civil War, John C. Alford served in Company D, 7th Battalion under Captain W. H. Crawford. According to a pension application filed 27 Dec 1919 by Sarah Annie Alford, they were married 2 March 1859. She was 22 years old at the time of their marriage, born 20 August 1838. John William Alford, son of Ruben Jones and Elizabeth Alford stated in the above application that John C. Alford served in the Civil war.) John C. Alford died 21 January 1909, Sarah Ann died in 1923.

In 1870, John C. and Sarah Alford were in Jefferys Township living next door to his father-inlaw, Reubin Jones. John is listed as age 52, born in South Carolina, with a birth date of 1818. Sarah's age is listed as 33 born in South Carolina with birth date of 1835. They now have four children, Sarah (Rebecca), Ellen, Reuben (Caldwell), and Louisa (Jane). William Alford, age 47 and Eliza Alford, age 37, are next door in house # 21. In house # 22 is David Bailey, whose wife Mary is the daughter of Reubin Jones. In house # 25 is Lizzie Alford age 53 with Unity and Ann. Reubin Jones is the only person listed with real estate (\$500) and personal property (\$170) values.

John was listed as J. C. Alford, age 63, in the 1880 census. He and Sarah, age 45, are still living in Jefferys Township with five children, S. Rebecca, a 21, Caldwell, a 13, L. Jane, age 10, Julia, age 7, and Nancy, age 3.

Rhoda Jones did not stay with her parents, Reubin and Louisa Jones. She is listed with a family of Alfords composed of Alford women, a "family" group that continued through 1920. The basis for this group are the daughters enumerated with Prudence Alford in 1850. It appears that they took in various family members. Maranza Alford, daughter of Sarah married James Wiggins and moved next to Prudence.

The 1900 census has John, Sarah and Sarah Rebecca still in Jefferys Township, Florence, SC. His age is given as 84, wife Sarah age 63, and daughter Sarah Rebecca age 40. Sarah had 10 children and only five are alive in1900, Sarah Rebecca, Caldwell, Louisa Jane, Julia M., and Nancy. Susannah Gore is two houses away with six children born and one living. This is most likely John's sister, Susan, who married Elias Gore per oral history (not proven). Sarah Rebecca was not married at this time. Caldwell married Bonnie Cain, Louisa Jane married Edward Pinckney "Ned" Gore , and Nancy married William Frank Hyman. There is no further information on Julia at this time.

The 1910 census shows Sarah A. Alford age 73, living in Cain Township with her daughter, Sarah Rebecca. Sometime after 1910 Rebecca married William Jenson and her mother, Sarah, moved in with her youngest daughter, Nancy, who had married William Hyman. Rebecca was more than 50 years old when she married and had lived at home with her parents all this time. John C. died in 1909 so maybe she had a beau all this time and decided to marry him after her father died, who knows!

The Report of the State Officers Board and Committees to the General Assembly for fiscal year 1911 notes that John was enrolled in the Confederate Pension Program in 1908. He received his pension for the fiscal year of 1910 (7- 09 to 7-10) but was noted as "dead" in the report for the fiscal year of 1911. Sarah A. Alford was enrolled in 1910. So Sarah picked up his pension after

he died. As already noted, under the Act of 1919, she applied for a second pension listing herself as C-4. (Widow's pension) Sarah Ann Alford died 25 August 1922.

Oral family history relates that John died in 1909 while on a trip to Newport News, Virginia, to visit family, and was buried there. A research trip made to Newport News in 2010 to investigate this story was unsuccessful. Recent records seem to indicate that he was buried at Mt. Elon Church in Florence County where Sarah Ann Jones Alford is buried.

After much research, grief, and pain, I came to the conclusion that only DNA testing would determine the father of John C .Alford. (I sponsored DNA for Harris Alford, descendant of William N. Alford, son of Prudence. To my knowledge, the DNA has not connected to a known Alford Line.) Based on available information, I believe my John C. Alford's mother was Prudence. So, to do DNA testing, I had to find a living male heir. I went hunting for John C's only son, Caldwell. Caldwell married Bonnie Cain, they had seven children: Ruth, John, Mintylene, Marie Elizabeth, Hyacintha, Nathan Alfonso, and June Caldwell. Unfortunately, John, Nathan and June only had girls so the DNA option is not available.

June Caldwell was born in 1908, but not listed in the 1910 census. I have been unable to find him in 1910.

The children of Caldwell Alford and Bonnie Cain married: Ruth married Spurgeon Bailey (her first cousin); John Jeffery married Ruby Hendrix, Clara Mae Blackwell (niece of Ruby Hendrix) and Margaret Plessinger; Mintylene married James Wiggins; Marie married Charles Foster; Hyacintha married Lewis Williams and N. J. Jones; Nathan Alfonse married Jettie Hendrix; and June married Annie Inu and Maude Crofton. All of the children went to the Newport News area except Nathan Alfonso and Ruth who stayed in Florence, SC

Except for the above individuals I have been unable to find the rest of the family in the 1920 census. All of the males from Caldwell's line do not appear to have any male children, so the DNA option is out.
