Isaac Alford named in Julius Alford's will, Bute County, North Carolina, 24 July 1766, recorded November 1771.

[Not in 1790 census but in 1800 Franklin County; 2 males under 10, 1 male 15-25, 2 females 15-25, 1 female 25-45.]

Wake County Superior Court, Autumn 1816: The State Bank vs Peyton Alford, Joseph Freeman, Cade Alford, Isaac Alford, \$511.73 + \$8.67½.. Marked "satisfied".

Additional to Watson's from Deed Book: Franklin County Deeds, Book 1, Page 91. "Isaac Alford's Spring Branch"

1778 - Isaac, Goodridge, John, Isum, Alford took Oath of Allegiance to U.S.

Isaac Alford from Jenkins Devany, Sheriff, 10 May 1799; A judgment had been granted against the guardian of Lodwick Alford, Hardy Hunt, for debt, and 373 acres were sold adjoining Wm. Andrews, Jr., John Tanner, Bailey Alford, Barneby Butler, Micajah Butler. Isaac Alford highest bidder for £73, recorded December 1801.

auction 12 November 1820. \$31.00 bid by William Clifton. Recorded March 13, 1822, Josiah Dilliard, James C. Barbee, witnesses.
