Your kind response to the announcement of the ALFORD FAMILY BULLETIN is very encouraging.

Since your interests are all so varied I have chosen to start with charts of those on whom I have notes from wills or census records. I hope to have later permission from copyright owners the right to quote from published acceptable records.

We hope to include other family charts (which we expect to have comments on) and also census records. Included in this issue is the chart of Jacob Alford of St. Tammany Parish, Louisiana (my daughter's ancestor), who was granted land there in 1809. In researching this family we found conflict with other records, hence our decision to publish our notes hoping to clear up in our own mind at least the contradiction we encountered.

We have recently taken off the 1880 Soundex of the Census (re the name ALFORD) for the following States - Alabama, Georgia, Louisiana, part of Kentucky and some of Mississippi. Before we publish them we will check the original volumes to find the place of birth of the parents of the heads of the household mentioned in the Soundex. Later we will run the Soundex 1880 for the States of Maryland, North and South Carolina, Texas, Virginia and West Virginia, where we know some of that named lived.

For those of you who are not familiar with the Soundex System, it lists those who have in their household a child under 10 years of age by a filing system, alphabetic for the first letter of the surname and numeric thereunder, keeping together names of the same or similar sounds but of different spellings. It gives the county, volume number, enumeration district, sheet number and line where the individual name occurs and the relation of each member to the head of the household.

Our feeling is that usually some member remains in the county where the family formerly lived or returns there later, we have proven this several times in our research.

Your contributions of material and your comments (with established proof) are most welcome.
