24. **John Alford** b. about 1786, North Carolina or maybe Tennessee, m. Jan 13 1811, in Grainger Co., TN, **25. Jane McElhattan**, b. about 1791, North Carolina, d. after 1860, Carroll Co., AR. John died 1860/70, Carroll Co., AR. A Grainger Co., TN record states that in November 1804 he was age 18, an orphan. He was bound to Thomas Mann to learn art, trade and master of millwright. TN census) Thomas H. Alford and Thomas's family. Supposedly when Thomas enlisted in the CSA, they went back to TN, but no further record of them has been found.

NOTE: DNA tests prove that descendants of this branch and those of several other yet "unconnected" branches of the Alford family do have some common Alford ancestor.
