Great Grand Parents

Jesse Alford b. May 1836, Edgecombe Co., NC, m. Oct 4 1859, in Edgecombe Co., NC,
9. Della (Madry) Dowling, b. May 15 1843, d. May 15 1923. Jesse died aft 1900. He was enumerated in 1860 and 1870 Edgecombe Co near his father. In 1880 He nd his family were in Hamilton, Martin Co. NC. In 1900 he and family were back in Edgecombe Co.

 Edmund Alford b. 1814, Edgecombe Co., NC, m. (1) Jun 8 1831, in Edgecombe Co., NC, 17. Sarah Jones, b. 1815, m. (2) Nov 7 1849, in Edgecombe Co., NC, Jane Pittman, b. 1834.

CENSUS:

1850? Where was he? Probably without wife but with five or six children?

- 1860: Edgecombe Co. Tarboro PO page 503, house 1026, family 955 enumerated July 11, 1860 (as Alfred all born NC): Edward 45 farmer \$1000 personal property, June 26, Mahalia 20, Rutha 16, Jensey 14, Cromwell 12, Louisa 7, Sarah 6, Montgomery 3, Dora Allen (m) 6 months. Son Jesse 25 and his bride Della were enumerated Jul 17 in Tarboro, page 519, house 1176, family 1101.
- 1870: Edgecombe Co. Tarboro PO, Deep Creek Township, page 9, house 132, family 147 enumerated July 6, 1870 (as Alford all born NC): Edward 53 farmer \$30 real property and

\$100 personal property, Jane 38, Laura 17, Sarah 15, Montgomery 13, Joanne 10, Thaddeus 6 and Mary 2. (It appears that the child county as male Dora Allen in 1860 was in fact female Joanne.) Son Jesse and his family were enumerated nearby on Jue 9.

1880: Edgecombe Co., Upper Conetoe, (as Alford all born NC): Edmond 69, Jane 47, Sarah 24, Montgomery 23, Joanne 18, Thadeus 15. Also in the household were Laurine Madra 24 and Charlie King 13. Son Jesse was in Martin Co. in 1880

3rd Great Grand Parents

- 32. Jesse Alford b. bef 1765, North Carolina..
- This branch of the Alford family was in North Carolina from the time of the 1790 census and before.
- 1790 Pitt Co., Newbern Jesse 1-1-1 which means one male 16 or older, one under 16 and one female.
- 1800 Pitt Co. Jesse 41010-00010 which means four sons age 0-9 and 1 age 10-15.
- 1810 Pitt Co. Jesse 31101-10002 means three sons 0-9, one 10-15 and 16-25. There was a daughter 0-9 and the second older female may have been his mother or a sister.
- 1820 Pitt Co. Jesse 100101-00102 says he has a son 0-9 and one 18-26. There was a daughter 16-26 and there was still the two older women. It is interesting to note that in 1820 on the same page with Jesse was the family of Margaret born before 1775. Included were two sons under ten, two daughters under ten and a daughter 26-45. (We are saying "sons" and "daughters" but it would be more correct to say "males" and "females." It is suspected that the census or the AAFA census extraction missed Margaret's family in 1810.
- 1830 Edgecombe Co. Jesse 00000001-000000011. This would be Jesse and his wife, now age 50-60 along with an older female. Margaret's family is gone as quickly as they appeared.
- 1850. There are some gaps in the census data here. All in the AAFA extract that might be this branch of the family is a Margaret A. Alfred age 9 enumerated in Stancills District, Pitt Co., with the family of Hardy G. Parker and wife Sarah.
